- 15 Chestnut Place: Permit submitted for tree removal. Permit approved by all Commissioners, fee paid in full. File closed.
- 6 Brownstone Way: Residents would like to have one tree inspected for removal.
Comm. K. Mitchell to do inspection and report back on findings.
- 2 Conifer Lane: Residents are concerned with one tree, claims the tree is dead/diseased and would like the tree inspected on safety concerns.
Comm. Chase will do inspection and report back on his findings.
- 610 N. Maple Ave: Property owner would like to have an inspection on the tree that uprooted the sidewalk.
Commissioner Raimondi will do inspection and report back of his findings.
